	105. CURRICULUM DEVELOPMENT
1. Purpose Title 22 Sec. 4.4, 4.13	The Board recognizes its responsibility for the development, assessment and improvement of the educational program of the schools. To this end, the curriculum shall be evaluated, adapted and developed on a continuing basis and in accordance with a plan for curriculum improvement.
Pol. 113, 115	Recognizing the fact that all students do not learn at the same rate, the Board endorses a curriculum designed to meet the various needs of the school population. The Board also supports offering opportunities for instruction in vocational areas to provide training for immediate entry into the job force following graduation, as well as academic preparation for students to assist them in becoming competent individuals prepared to assume a positive role in society.
2. Definition Title 22 Sec. 4.3	For purposes of this policy, curriculum shall be defined as a series of planned instruction that is coordinated, articulated and implemented to result in achievement of specific knowledge and skills, and application of such knowledge, by all students.
3. Authority Title 22 Sec. 4.4, 4.12 Pol. 102	The Board is responsible for the curriculum of the district's schools. The curriculum shall be designed to provide students the opportunity to achieve the academic standards established by the Board and to offer a range of instructional choices.
Title 22 Sec. 4.4, 4.13 SC 1512 Pol. 107	In order to provide a quality educational program for district students, the Board shall adopt a curriculum plan that includes the requirements for courses to be taught; subjects to be taught in the English language; courses adapted to the age, development and needs of students; and a remediation plan for students not achieving proficiency.
4. Guidelines	The district's curriculum shall provide the following:

	Organization Of Instructional Program
Pol. 106, 107	The Bermudian Springs Elementary School shall operate a basic skills academic program, as specified in the district's planned course of study guide. Planned course outlines in the elementary grades shall emphasize the need for building strong foundations in verbal and mathematical skills, while offering a broad range of learning activities that will enhance intellectual, social, physical, and emotional growth. The foundation for the elementary curriculum is the state curriculum regulations.
	Instruction in the middle school grades shall build on the foundations developed in the elementary grades, while including more concepts dealing with personal growth. The curriculum at this level includes the state curriculum regulations. The middle school curriculum shall serve to meet the unique needs of early adolescents, while aiding the maturity process important for high school readiness.

	Students attending Bermudian Springs High School shall be offered a comprehensive selection of required and elective courses in the following areas: academic education, business education, and vocational education. Through careful planning and the consideration of a suggested sequence of courses, each student will be able to meet his/her academic and/or vocational needs while attaining the requirements for graduation.

	The Superintendent shall report periodically to the Board each pilot program, along with its objectives, evaluative criteria, and costs.
	The Board encourages, where it is feasible and in the best interest of district students, participation in state-initiated pilot programs of educational research.
